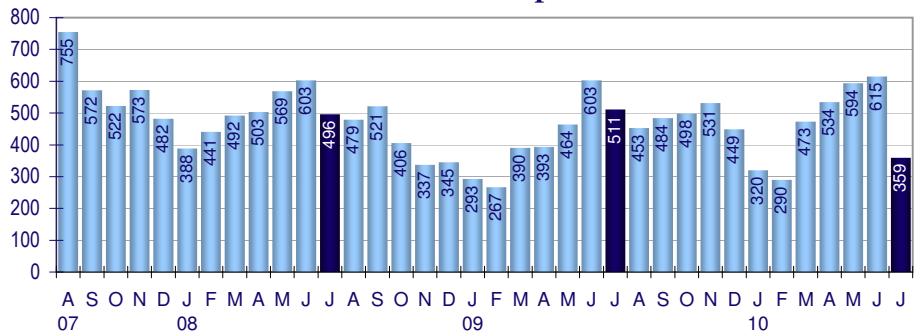

Property Sales

July Property sales were 359, down 29.7% from 511 in July of 2009 and 41.6% lower than the 615 sales last month. July 2010 sales were at their lowest level compared to July of 2009 and 2008. July YTD sales of 3,185 are running 9.0% ahead of last year's year-to-date sales of 2,921.

Prices

The Median Sales Price in July was \$157,000, down 10.3% from \$175,000 in July of 2009 and up 1.3% from \$155,000 last month. The Average Sales Price in July was \$186,300, down 6.9% from \$200,176 in July of 2009 and down 3.6% from \$193,164 last month. July 2010 ASP was at the lowest level compared to July of 2009 and 2008.

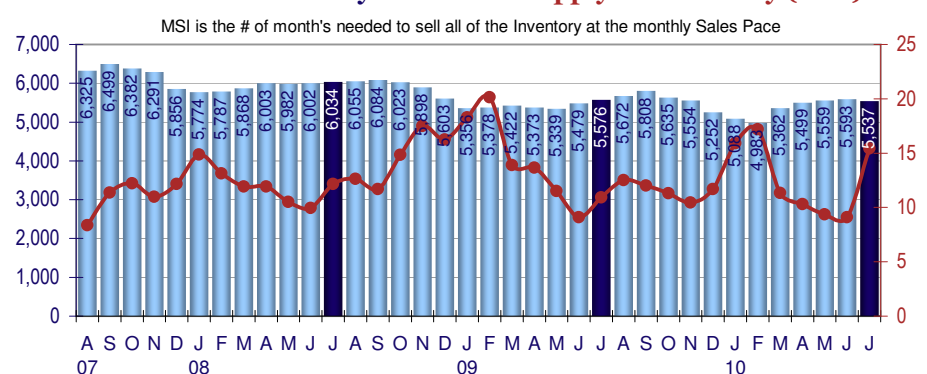
Median Sales Price and Average Sales Price



Inventory & MSI

The Total Inventory of Properties available for sale as of July was 5,537, down 1.0% from 5,593 last month and down 0.7% from 5,576 in July of last year. July 2010 Inventory was at its lowest level compared with July of 2009 and 2008.

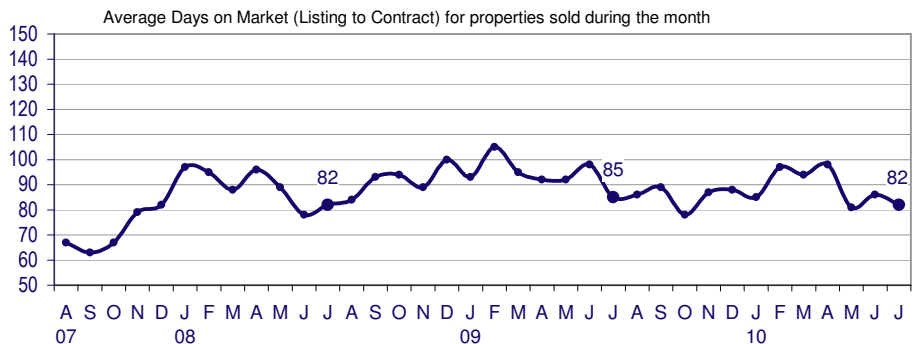

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for July was 82, down 4.7% from 86 days last month and down 3.5% from 85 days in July of last year. The July 2010 DOM was at its lowest level compared with July of 2009 and 2008.

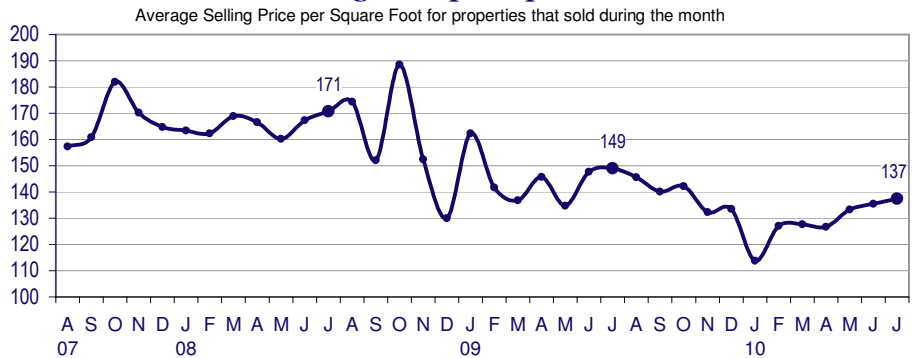
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The July 2010 Selling Price per Square Foot of \$137 was up 1.5% from \$135 last month and down 7.8% from 149 in July of last year.

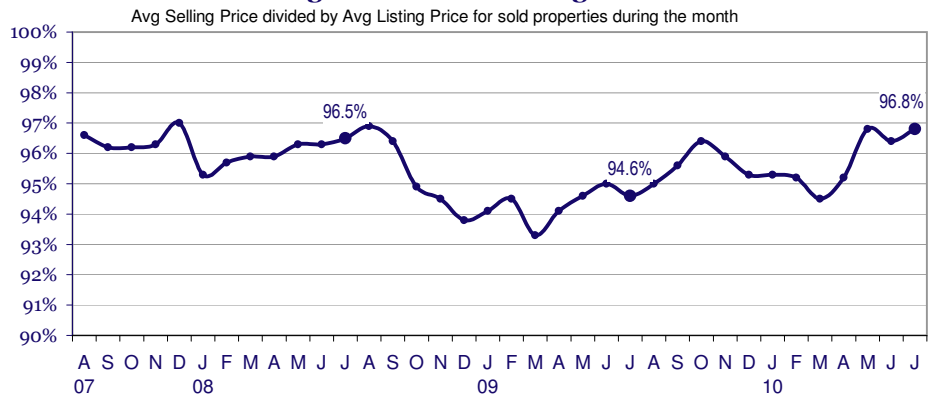
Selling Price per Square Foot



Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The July 2010 Selling Price vs Original List Price of 96.8% was up from 96.4% last month and up from 94.6% in July of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in July 2010 was 1,282, down 1.3% from 1,299 last month and down 0.2% from 1,285 in July of last year.
