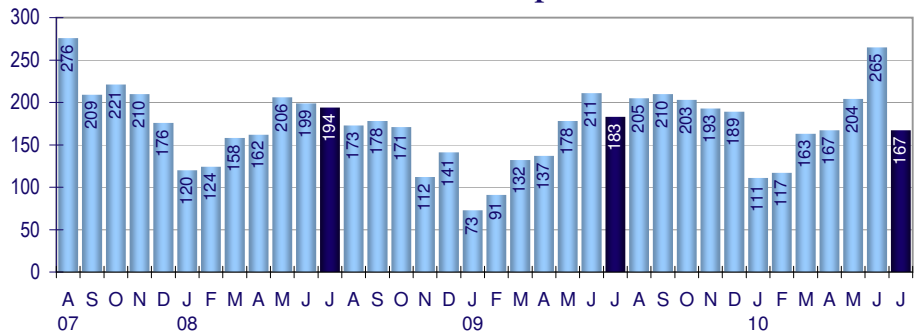

Property Sales

July Property sales were 167, down 8.7% from 183 in July of 2009 and 37.0% lower than the 265 sales last month. July 2010 sales were at their lowest level compared to July of 2009 and 2008. July YTD sales of 1,194 are running 18.8% ahead of last year's year-to-date sales of 1,005.

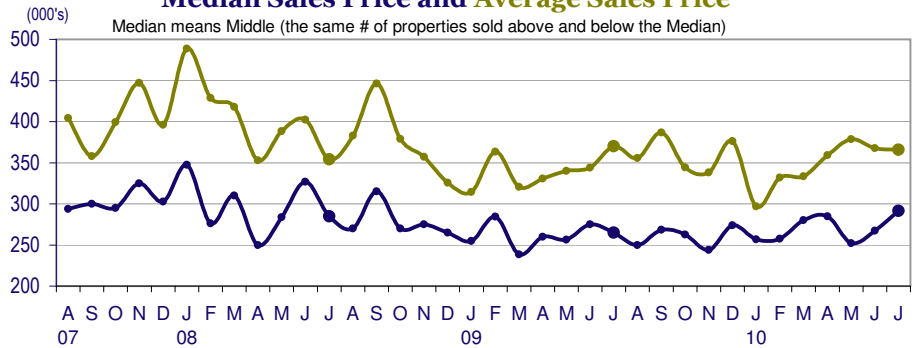
Number of Properties Sold



Prices

The Median Sales Price in July was \$291,500, up 10.0% from \$265,000 in July of 2009 and up 9.0% from \$267,500 last month. The Average Sales Price in July was \$365,939, down 1.1% from \$369,889 in July of 2009 and down 0.5% from \$367,678 last month. July 2010 ASP was at a mid range compared to July of 2009 and 2008.

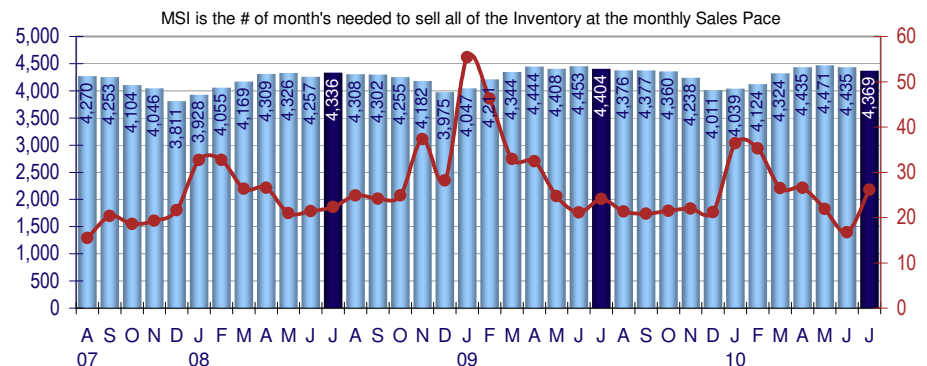
Median Sales Price and Average Sales Price



Inventory & MSI

The Total Inventory of Properties available for sale as of July was 4,369, down 1.5% from 4,435 last month and down 0.8% from 4,404 in July of last year. July 2010 Inventory was at a mid level compared with July of 2009 and 2008.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The July 2010 MSI of 26.2 months was at its highest level compared with July of 2009 and 2008.

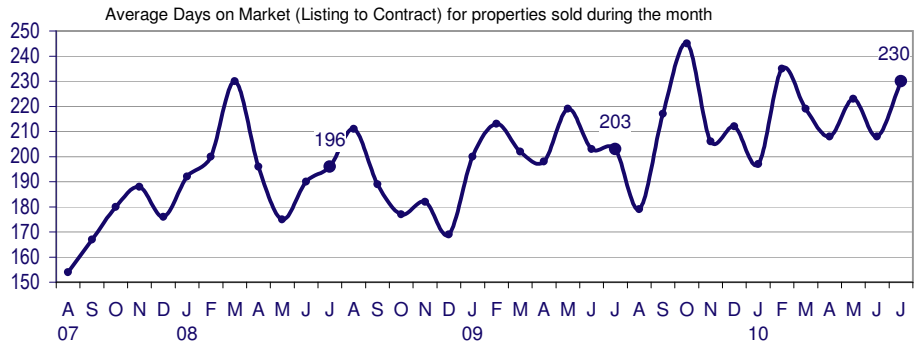

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for July was 230, up 10.6% from 208 days last month and up 13.3% from 203 days in July of last year. The July 2010 DOM was at a mid level compared with July of 2009 and 2008.

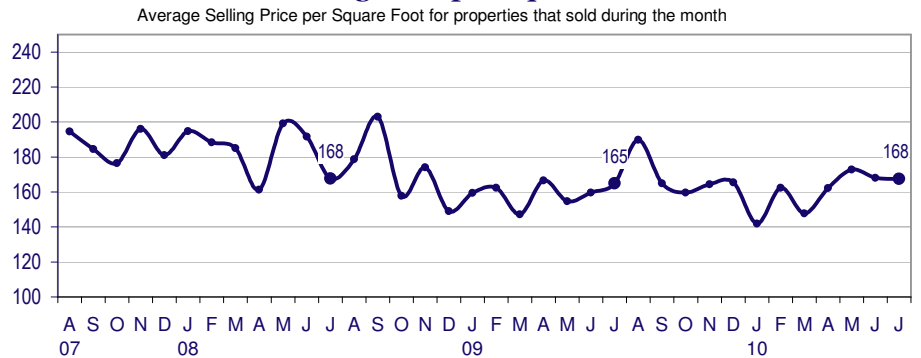
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The July 2010 Selling Price per Square Foot of \$168 was down 0.3% from \$168 last month and up 1.6% from 165 in July of last year.

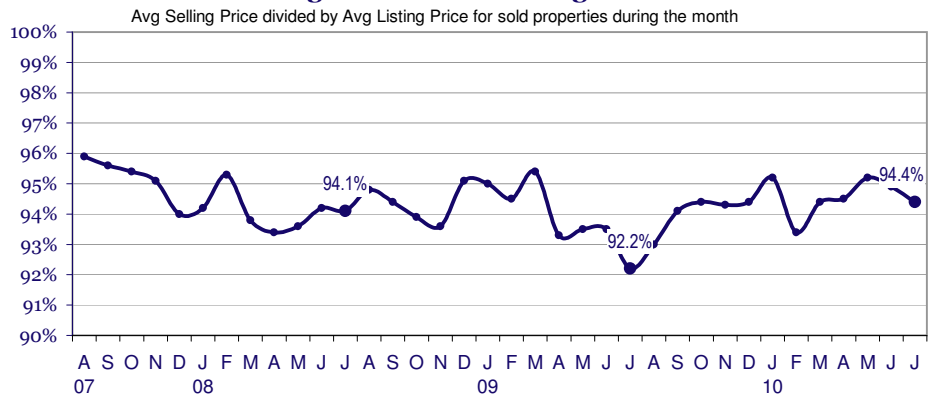
Selling Price per Square Foot



Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The July 2010 Selling Price vs Original List Price of 94.4% was down from 94.9% last month and up from 92.2% in July of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in July 2010 was 456, down 5.2% from 481 last month and down 3.8% from 474 in July of last year.
