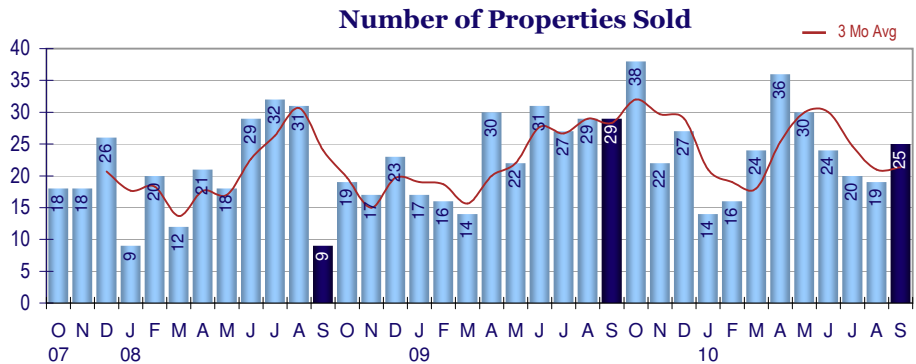

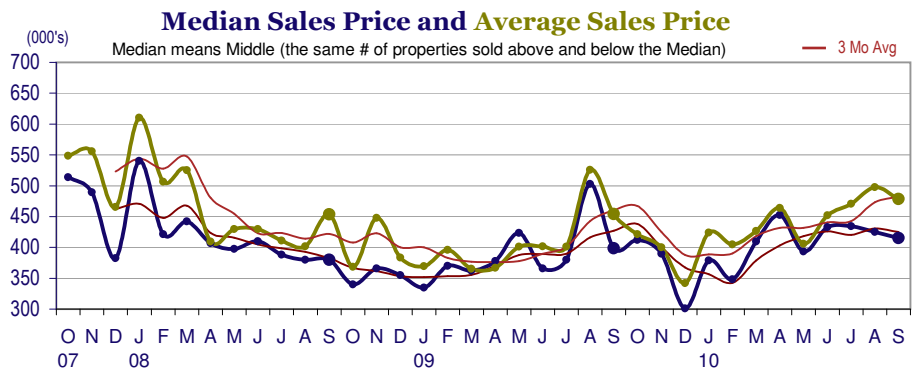
Property Sales

September Property sales were 25, down 13.8% from 29 in September of 2009 and 31.6% higher than the 19 sales last month. September 2010 sales were at a mid level compared to September of 2009 and 2008. September YTD sales of 208 are running 3.3% behind last year's year-to-date sales of 215.



Prices

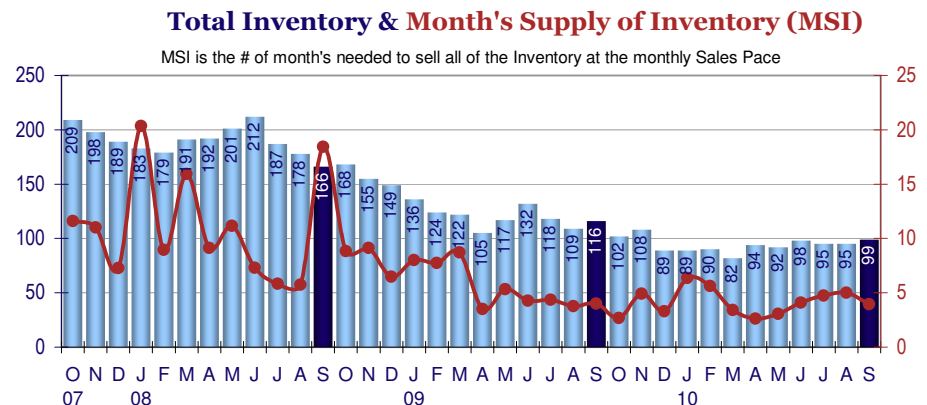
The Median Sales Price in September was \$415,000, up 4.2% from \$398,400 in September of 2009 and down 2.4% from \$425,000 last month. The Average Sales Price in September was \$478,465, up 5.4% from \$454,061 in September of 2009 and down 3.8% from \$497,566 last month. September 2010 ASP was at the highest level compared to September of 2009 and 2008.



Inventory & MSI

The Total Inventory of Properties available for sale as of September was 99, up 4.2% from 95 last month and down 14.7% from 116 in September of last year. September 2010 Inventory was at its lowest level compared with September of 2009 and 2008.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The September 2010 MSI of 4.0 months was at its lowest level compared with September of 2009 and 2008.

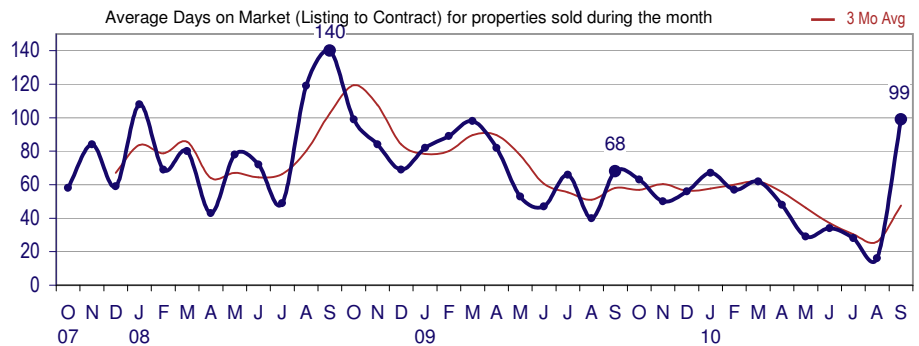

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for September was 99, up 518.8% from 16 days last month and up 45.6% from 68 days in September of last year. The September 2010 DOM was at a mid level compared with September of 2009 and 2008.

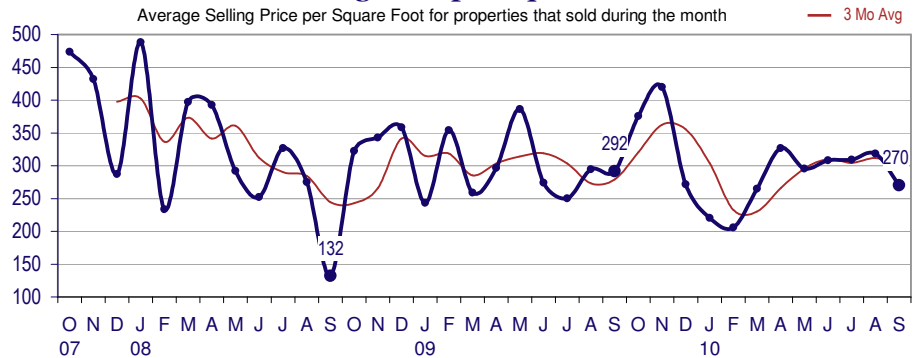
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The September 2010 Selling Price per Square Foot of \$270 was down 15.1% from \$318 last month and down 7.4% from 292 in September of last year.

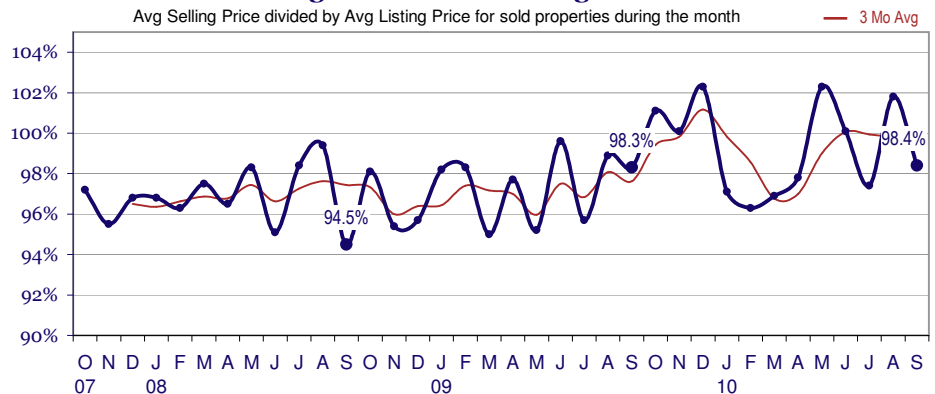
Selling Price per Square Foot



Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The September 2010 Selling Price vs Original List Price of 98.4% was down from 101.8% last month and up from 98.3% in September of last year.

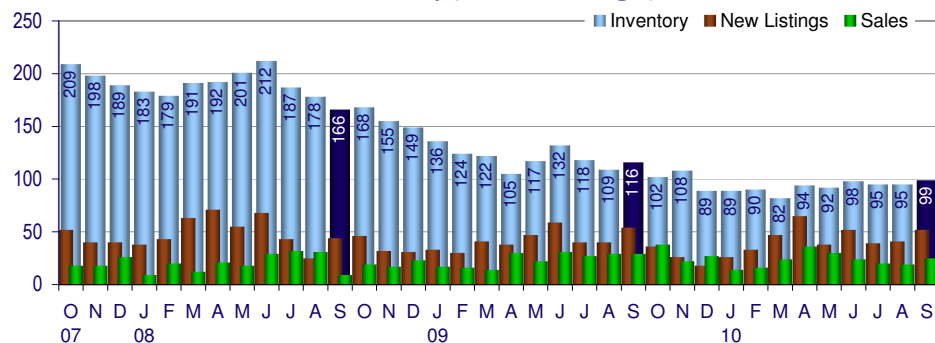
Selling Price versus Listing Price Ratio

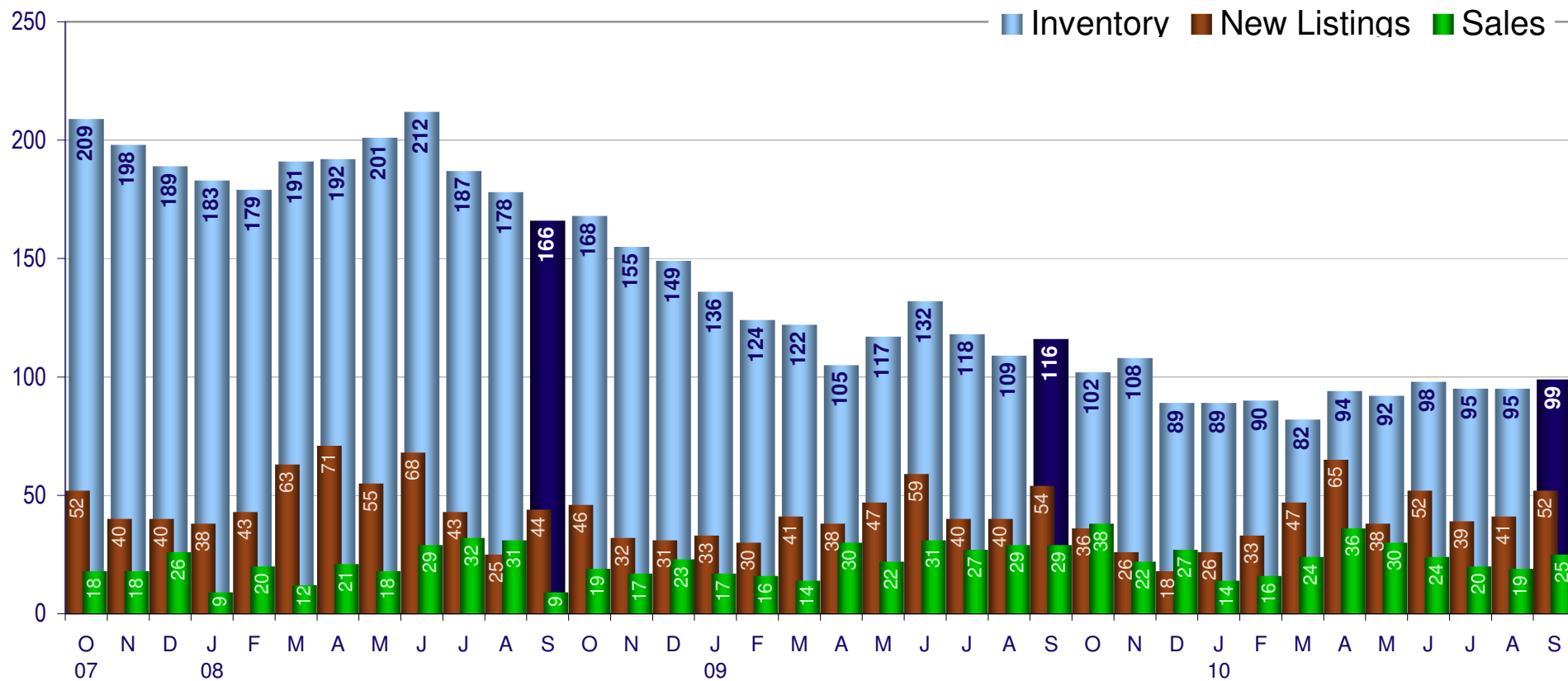
