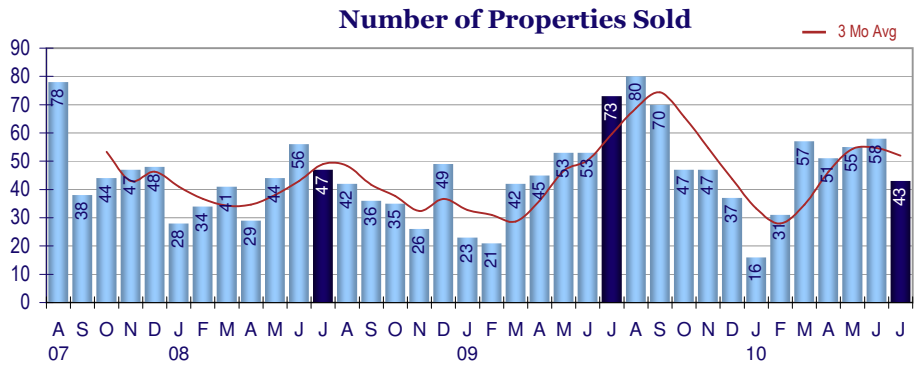

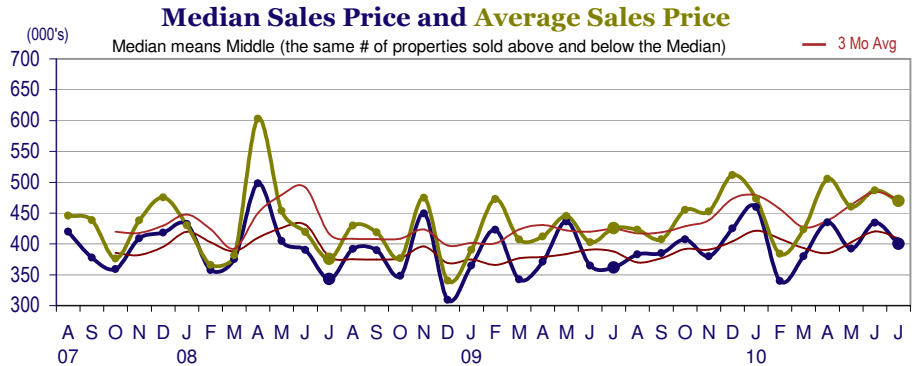
Property Sales

July Property sales were 43, down 41.1% from 73 in July of 2009 and 25.9% lower than the 58 sales last month. July 2010 sales were at their lowest level compared to July of 2009 and 2008. July YTD sales of 311 are running 0.3% ahead of last year's year-to-date sales of 310.



Prices

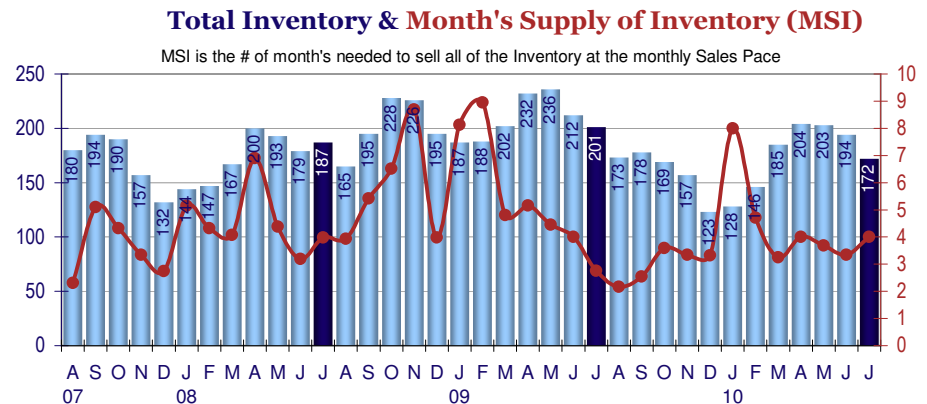
The Median Sales Price in July was \$399,900, up 10.6% from \$361,700 in July of 2009 and down 7.9% from \$434,250 last month. The Average Sales Price in July was \$469,906, up 10.4% from \$425,564 in July of 2009 and down 3.5% from \$486,718 last month. July 2010 ASP was at the highest level compared to July of 2009 and 2008.



Inventory & MSI

The Total Inventory of Properties available for sale as of July was 172, down 11.3% from 194 last month and down 14.4% from 201 in July of last year. July 2010 Inventory was at its lowest level compared with July of 2009 and 2008.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The July 2010 MSI of 4.0 months was at its highest level compared with July of 2009 and 2008.

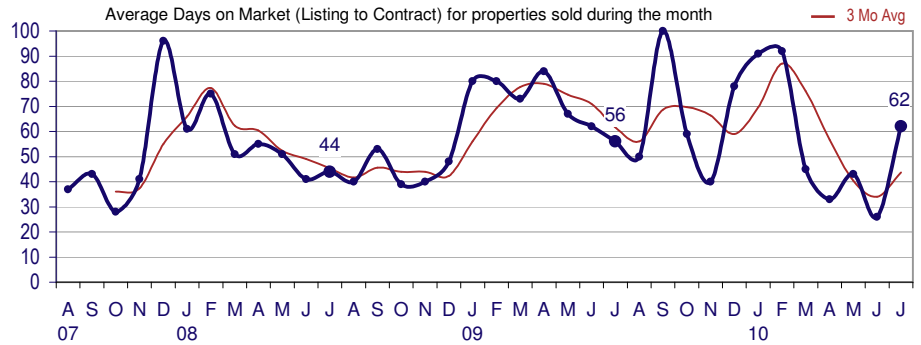

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for July was 62, up 138.5% from 26 days last month and up 10.7% from 56 days in July of last year. The July 2010 DOM was at a mid level compared with July of 2009 and 2008.

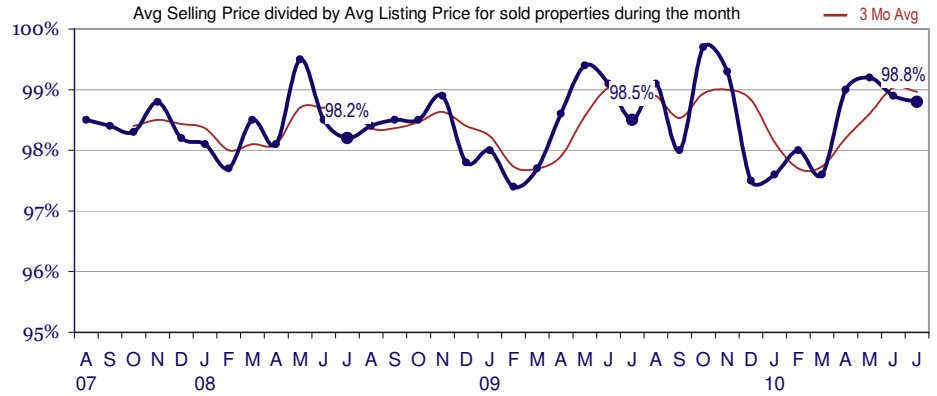
Days On Market for Sold Properties



Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The July 2010 Selling Price vs Original List Price of 98.8% was down from 98.9% last month and up from 98.5% in July of last year.

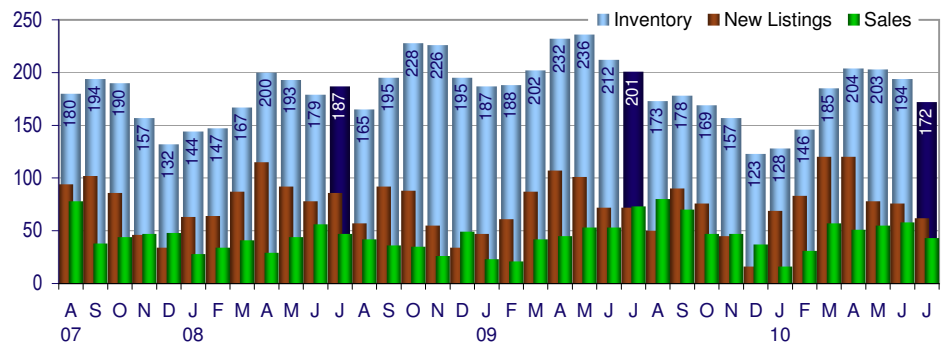
Selling Price versus Listing Price Ratio

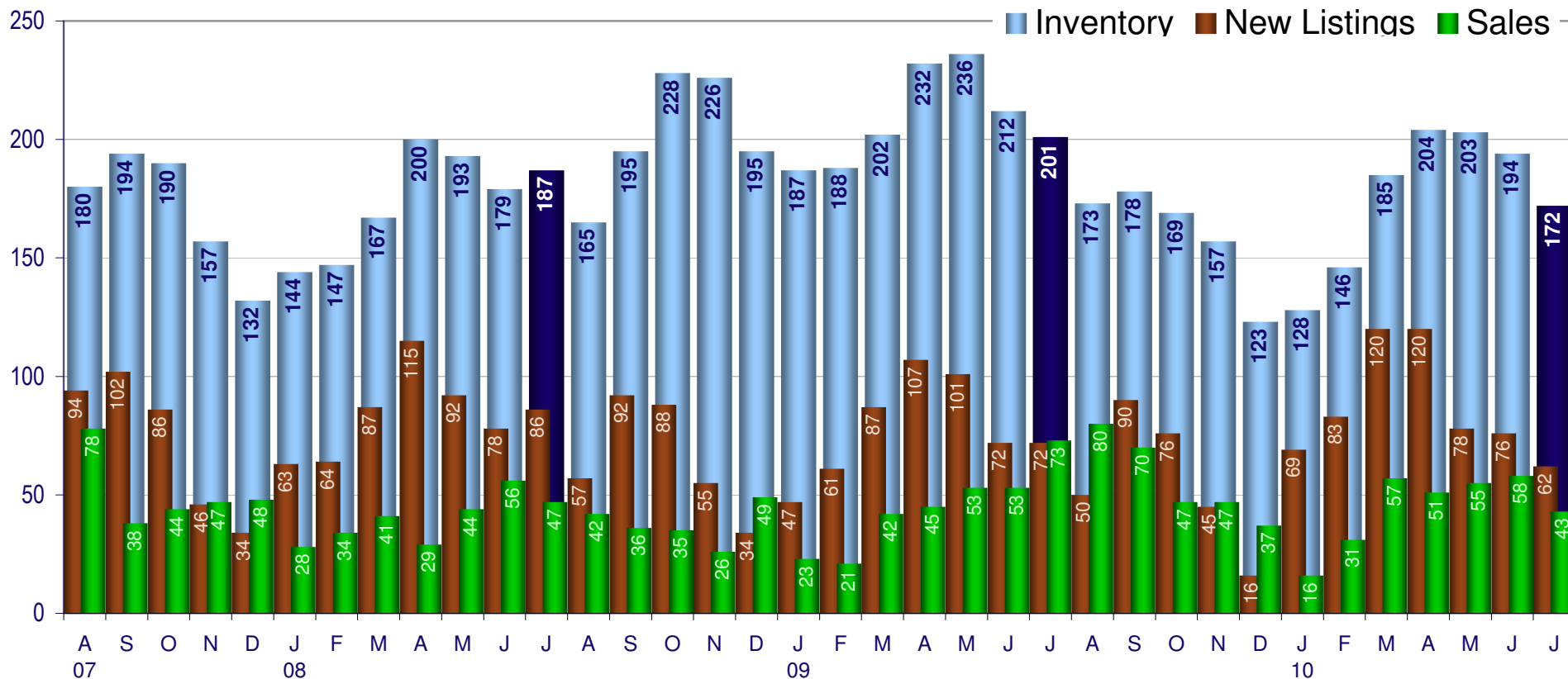
